Clinical Cases in Mycology: What's New in the World of Fungi

DESCRIPTION

The means by which we identify fungal species and diagnose fungal infections are rapidly evolving with the availability of new technologies. In addition, fungal taxonomy and nomenclature are also rapidly changing due to the use of molecular tools to classify these organisms. However, invasive fungal infections remain difficult to treat due to various factors, including the development of resistance to antifungal agents. In this program, through case studies, we will review new methods for identifying fungi and discuss developments in antifungal resistance.

- Review new methods used for the identification of fungi and recent changes in fungal taxonomy
- Discuss recent trends in antifungal resistance for both yeasts and moulds
